**SUPPLY HEAD CLASSIFICATION AND DESCRIPTION**

<b>Supply Head</b>	<b>Title</b>	<b>Description</b>
SY01A	Essential Construction Materials under Part VIA of BCA Act	Supply of essential construction materials under Part VIA of BCA Act and its subsidiary legislation such as sand and granite aggregates. Requires import licence i for essential construction materials issued by BCA. Refer to <a href="http://www.bca.gov.sg/ImportersLicensing/importerslicensing.html">http://www.bca.gov.sg/ImportersLicensing/importerslicensing.html</a> for more details.
SY01B	Ready-Mixed Concrete	Supply of ready-mixed concrete. Requires Certificate of Conformity for Ready-Mixed Concrete issued by SAC
SY01C	Other Basic Construction Materials	Supply of other construction materials such as bricks, cement, timber and reinforcement bars. Requires agency rights.
SY02	Chemicals	Supply of all forms of chemicals including pollution dispersal chemicals, hardening compounds, adhesives solvents and paints.
SY04	Electrical Equipment	Supply of heavy electrical equipment such as switchgears and transformers. Firms must have facilities and personnel to provide maintenance back up services for the equipment supplied.
SY05	Electrical & Electronic Materials, Products & Components	Supply of electrical and electronic products and materials such as batteries, electrical cables and wires, lightings, and includes control and measuring instruments.
SY06	Finishing & Building Products	Supply of all finishing & building products such as carpets, tiles, ceiling boards, awnings, blinds, wallpapers, non-structural precast products.
SY07	Gases	Supply of gases including oxygen, nitrogen, hydrogen, nitrous oxide, chlorine, carbon dioxide and oxyacetylene gases.
SY08	Mechanical Equipment, Plant & Machinery	Supply of mechanical plants and equipment including generators, vehicles, air compressors, pumps, lathes, boilers, bulldozers, cement mixers, cranes and turbines. Weapons are excluded. Firms should possess facilities and personnel to provide maintenance and back-up services.
SY09	Mechanical Materials Products & Components	Supply of mechanical materials, products and components including ferrous and non-ferrous castings, machine tools, rollers, conveyor belts, valves and spare parts for mechanical equipment.
SY10	Metal and Timber Structures	Supply of aluminum, steel, steel alloy and timber structural components, metal scaffolds.
SY11	Petroleum Products	Supply of all petroleum products and by-products including lubricants, bunker oil, diesel, gasoline and greases. Equivalent synthetic product suppliers can also be considered for registration.
SY12	Pipes	Supply of all forms of pipes made of steel, concrete, PVC or their combination.
SY14	Sanitary Products	Supply of sanitary fittings including washing basins, bidets, toilet bowls and bathtubs. Supplier of pipes should be registered under SY12.

SY04	Electrical Equipment	<p>“P” shall mean a Professional qualification with a recognised degree in Mechanical/Electrical/Electronics Engineering or equivalent.</p> <p>“T” shall mean a Technical qualification with a recognised diploma in Mechanical/Electrical/Electronics Engineering or equivalent.</p>
SY08	Mechanical Equipment, Plant & Machinery	A holder of BCA Builder Certificate or NTC2 in mechanical/electrical trade can be considered for L1 to L3.

### SPECIAL CONCESSIONARY RULES

Except for SY01A, SY01B and SY01C, where a particular firm has insufficient track record but has the agency rights for the supply of certain products, BCA may permit the firm’s entry to the financial grade applied if their paid-up capital and net worth meet the following values (see Table B3).
